 - o Revenue \$38,175; Expenditures \$37,500
 - An increase in annual dues from \$175 to \$225 is necessary to cover increasing costs.
 - Joe Pondrom made the motion to approve the 2024 budget, to include an increase in annual dues. Jim Wilson seconded the motion.

Update on board composition and officers – Keith Brainard

- Sterling Woodard assuming patrol duties.

Covenants and enforcement update - Wade Todd

- Neighborhood patrols resumed on January 5, 2024 after a short holiday break.
- HOALife will be used in the future to manage and document violations.
- The Board discussed a disputed parking violation for overnight street parking.

Update on HOA management software – Sterling Woodard/Wade Todd

- Sterling Woodard and Wade Todd provided a demo of HOALife software.
 - HOALife will be replacing ManageCasa. HOALife provides greater functionality, customer support, ease of use, and better meets the HOA's management and oversight needs.
 - HOALife functionality:
 - communication
 - inspections and violation enforcement
 - architectural requests
 - maintenance reporting
 - property owner portal access
 - accounting, to include billing and integration with QuickBooks.
- Sterling Woodard to update the Board as the use of HOALife matures.

Codification of rules for HOA fines

- House Bill 614, 88th Texas Legislature Regular Session, took effect January 1, 2024 and requires HOAs to adopt an enforcement policy regarding the levying of fines. The bill requires the policy to include:
 - general categories of restrictive covenants for which the association is authorized to assess fines;
 - \circ a schedule of fines for each category of violation; and
 - information regarding hearings.
- Wade Todd will consult with association counsel to verify that current enforcement policy meets requirements of HB 614.

Update on landscaping services – Jim Wilson

- Mulch was added to medians. Spot treated medians for ants.
- Trees in medians are in need of trimming. Jim will obtain bids.
- Medians generally look better after irrigation and mulching efforts.

Landscaping and housing maintenance – Sterling Woodard

• Activities will resume in Spring 2024.

Neighborhood sign – Keith Brainard

- Keith Brainard suggested the "No Soliciting" sign be removed and replaced with a more permanent and attractive sign.
- Joe Pondrom recommended that the prohibition of soliciting needs to be verified in the covenants before a new sign is installed.
- Current sign will be removed.

Lighting of medians – Keith Brainard

• The Board discussed a resident inquiry to installing landscape lights in the medians. The Board determined that installing landscape lights in the medians is cost prohibitive.
