 4. **Treasurer's report** – Wade Todd
 - Landscaping expenses have been higher as planned.
 - There have been \$400 in fines, 3 home sales for \$1,050
 - Currently, there are 9 properties with balances, 8 for current year annual dues, 3 unpaid dues from last year.
 - Discussed putting some bank funds into a 4 month CD
 - Motion: Sterling Woodard makes a motion: “the HOA Board authorizes the treasurer to invest up to \$50K in CD’s for a period of time no longer than 6 months at a bank of their discretion.”
 - 2nd by Joe Pondrom
 - Motion passed
 5. Landscaping services update – Jim Wilson
 - Median project went well.
 - Irrigation Zone 12 broke and incurred an unplanned expense.
 6. Covenants and enforcement update – Sterling Woodard
 - 7 patrols for April.
 - Discussed various emails from homeowners.
 7. Review of Rules of Order and meeting proceedings – Wade Todd

8. Financial review committee – Wade Todd

 - Stephen to contact the three of them and discuss meeting time.
 - They will meet with Wade to review books for last year.
 - Motion by Joe Pondrom - “Move to appoint 3 names to the financial review committee.”
 - 2nd by George Brown
 - Motion passed.
9. Use of HOA email and website – Stephen Pahl
- As a reminder, Board should not select Reply All to emails to not conduct a “walking meeting”.
 - People wanting to use website to post announcements. We should direct people to use Next-door instead of HOA website for non-HOA matters.

11. Update on collection efforts regarding 108 River Down Road – Stephen Pahl
- Wade provides update. She did not respond to the 30 day appeal window for the initial judgement. She will now get a 20 day notice to respond. If not response, then there will be a 21-day notice for foreclosure.
 - We already have a judgement should there be a filing bankruptcy.

- Sent letter to the city and Georgetown Fire Department and Parks Department.
 - Stephen will reach out to meet with the decision makers.
